



## CHASTAIN HORSE PARK PONY PARTIES

Celebrate your child's birthday at Chastain Horse Park!

- Available for a party of up to 15 children aged 3 and older, year-round.
- Two hours of fun.
- Party location is the small upper barn. This barn boasts two indoor picnic tables, two outdoor tables, and a small private riding arena.
- Your party will include at least two age-appropriate "take home" crafts and one hour of riding.
- Children get "hands on" horse knowledge by decorating the ponies and meeting them before riding.

Chastain Horse Park will provide a coordinator and two horse leaders for each party of children 7 - 12 years old. For parties with children 3 - 7 years old, an additional staff member must be provided at the cost of \$50, to assist with arts, crafts, and games, allowing the parents to relax and enjoy this special occasion.

Bring your own food, beverages and decorations...we provide table coverings, set up, and clean up of your party. No adult alcoholic beverages allowed, and please do not bring food for the horses.

**EMERGENCY RELEASE:** In case of an emergency, I give permission to Chastain Horse Park to secure medical treatment including x-rays, anesthetic, medical or surgical diagnosis or treatment and hospital service rendered under the general or specific instructions of any physicians or hospital. The undersigned hereby agrees to pay all fees and expenses of doctors, hospitals, ambulances, and other medical expenses reasonably and necessarily incurred. This provision will only be invoked if the person listed below cannot be reached.

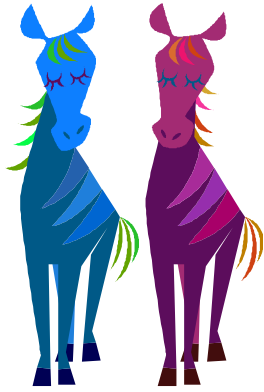

## HELPFUL PARTY TIPS from the PONIES at CHASTAIN HORSE PARK...

\* Park in the lot in front of the main clubhouse, using the entrance on Powers Ferry Road. Meet at the clubhouse steps at 2:45p, and you will be taken up to the party barn, where we will be waiting! (Do *not* drive up the private service driveway off of West Wieuca to pick up your child, as access is restricted to emergency vehicles and people with disabilities who cannot climb the steps.)

\* Wear closed toed shoes or boots, and barnyard friendly clothes. **NO SANDALS OR FLIP FLOPS!!!** Dress for the weather- this could mean coats and gloves since we ride outside! Riding helmets will be provided and are required while riding.

\* Although we ponies may love carrots and apples, it is important not to feed us! Some of us are on special diets.

\* For the safety of those at the party, please plan to stay in the designated party area. We don't want party-goers to startle other horses and riders on the premises (on the road and in the arenas).

\* Remember to bring your signed release form (enclosed). This is required for every child in order to ride. We always have extras at the party in case you forget!

\* Space in the barn is limited to 35 people (including parents). We have a certain number of craft projects and a limited time to ride, so we ask that you not bring along siblings that have not been specifically invited.

\* Be sure to listen to our party coordinators. They will go over rules about riding, barnyard safety, and some other things before the party begins.
